**Humboldt Bay Harbor Safety Committee USCG Report
January 18, 2024**

- **20NOV2023:** MSD duty personnel received a notification of a sunken 25ft pleasure craft that was discharging gasoline at the Eureka Municipal marina and had created a 100ft rainbow sheen. The marina placed sorbent material and boom around the vessel and the owner was notified. The vessel was ultimately floated and removed from the water. Enforcement pending.
- **06DEC2023:** MSD duty personnel received notification of a partially sunken sailboat, LOLLYGAGGER, in King Salmon. The harbor master of EZ Landing marina was contacted and reported that there was no sheening around the vessel and that all pollution sources had been previously removed from the vessel as it had been abandoned. OSPR responded to the scene the following day and confirmed there was no pollution from the vessel. Upon further investigation, the vessel had been involved in previous sinking cases however, the harbor master had no plans to remove the vessel. No further investigation required.
- **22DEC2023:** MSD duty personnel received a notification of a breach of security at the Chevron Refinery facility. A homeless man was discovered on the fuel barge inside of the tank farm/port facility. The Chevron representative stated the individual was escorted off of the facility and left the scene. Local PD was contacted but not dispatched.
