 - a. **Nuisance Vessels / Unseaworthy Vessels / Sunken Vessels / Abandoned Vehicles / Vessels / Debris Abatement / Oil Spills / Accidents / Incidents:** Scott Miller gave report.
6. **US Army Corps of Engineers Report:** Peter Mull gave report that the Bayport Dredge departed July 18, 2024. The post dredge survey is complete and pending release. Dredging is complete for this season. The Bar and Entrance channel is at 47 feet.

 - a. **Trinidad Harbor:** None.
 - b. **City of Eureka Marina:** D. Wilkes gave report on Save 22 Grant, fully executed, 5 vessels removed. Applied for Save 24 to remove 6 more vessels. On June 30th, a vessel sunk at the City Marina. Hoist to be rebuilt off Fishermen’s Terminal. Hoists going in at Triple G Seafood are not public.
