1. **Committee and Meeting Attendee Introductions were made. Pledge of Allegiance. Roll Call.**
2. **Public Comment:** None.
3. **Consent Calendar:**
 - a. **Approve Meeting Minutes from March 21, 2024:**

5. **USCG Reports:**
 - a. **Nuisance Vessels / Unseaworthy Vessels / Sunken Vessels / Abandoned Vehicles / Vessels / Debris Abatement / Oil Spills / Accidents / Incidents:** Mark Hamerling gave report on incidents from March to May 2024.
 - b. Rob Canepa gave an update regarding bar reports. Short staffing may affect response.
6. **US Army Corps of Engineers Report:** Peter Mull gave report that the Essayon Dredge will not be available due to scheduling and other contracts for dredging in June. Manson Bayport expected June 17th for Bar and Entrance dredging. Yaquina completed 10 days of dredging on priority areas and removed approximately 25,000 cy. Official surveys to come.
7. **Port/ Harbor/ Marina Reports:**
 - a. **Trinidad Harbor:** None.
 - b. **City of Eureka Marina:** D. Wilkes gave report on Save 22 Grant, removed 4 derelict vessels from City of Marina Public Marina, preparing to remove another 49ft derelict vessel from the Marina. Applied for Save 24 to remove 6 more vessels. Work to commence in August for new pilings and fenders for Fishermen’s Terminal. F Street Guest Dock timbers broke, Dock is tied up at Caito Dock pending repair ASAP. New hoist approved for Triple G Seafood. Upcoming Kinetic Race May 27.
 - c. **Port of Humboldt Bay:** Amber Shehan gave report, crab season ending. Lien sales held at Woodley Island Marina.
8. **OSPR Reports:** Reuben Macaspac gave an update on membership that Jonathan Bishop was re-appointed to 4 committees at once including Humboldt Bay on April 3rd. Chris Mikkelsen to take oath in July for Primary Member for Port Authority. Jeff Dayton gave a report that there will be no ACP meeting in May. Draft for Klamath River Geographic Response Plan in progress.

 - b. **Local Law Enforcement:** None.

- c. **State Lands/Coastal Commission:** Jonathan Bishop gave update, travel freeze, unable to attend meetings in person.
- d. **Bar Pilots:** Leroy Zerlang gave report that Paul Casken is to test for pilotage. M. Lee withdrawn from program, moved to Oregon. No cruise ships expected in 2024. Currently at 32 ft draft restriction due to shoaling.
- e. **Tank Barge:** Ross McDonald reported expecting Morro Bay on May 18th and will check when Koos King is set to be re-powered.
- f. **Dry Cargo:** Colin Campbell reported barge Glorious Peony expected in May. Next ships in August due to maintenance.
- g. **Tug Operators:** Leroy Zerlang gave report, Fashion Blacksmith out of business in Crescent City. Research vessels for Offshore Wind expected in June. 2 Foreign flagged vessels and 1 US flagged vessel to dock at Fairhaven Terminal.
- h. **Tribal/Environmental:** None.
- i. **Commercial Fishing:** Jake McMaster gave brief report on crab season.
- j. **Recreational Boater Safety:** Kent Hulbert gave report, fishing for Halibut and Near Shore Rockfish. Bridget Hand-Nichols gave a report that the Aquatic Center will have a different schedule this season and will be open during favorable tides. Check the website for details.
